<b>Intended Learning Outcomes (ILOs):</b>					
<p>Students write two project works (BQ06 and BQ07) during their Bachelor programme, which will be accompanied by a colloquium. Aim of the project work is to demonstrate that the students are able to elucidate autonomously a scientific subject during a set time frame in a written and/or oral form, to structure and to evaluate it. The colloquium prepares for drafting the project work and enables furthermore the acquisition of key competences.</p> <p>By the end of the module, students will be able to</p> <ul style="list-style-type: none"> <li>- elucidate autonomously a scientific subject during a set time frame in a written and/or oral form, to structure and evaluate it,</li> <li>- name and adopt rules of the diligence for drafting scientific papers and/or presentations,</li> <li>- plan and autonomously implement work steps for drafting an academic work and/or presentations,</li> <li>- conduct literature researches, evaluate literature sources critically and adopt methods of quotations (also in presentations),</li> <li>- use software for drafting project works and presentations (possibly also with literature management),</li> <li>- implement techniques of good scientific presentations,</li> <li>- create group work expediently,</li> <li>- adopt feedback rules</li> <li>- reflect the own way of working</li> </ul>

<b>Description/Contents:</b>					
The content of the project work results from the course contents of the selected optional compulsory course and is determined by the lectures of the modules. The project work aims to					

prepare for the bachelor thesis. The Colloquiums amplify the knowledge in scientific working techniques and methods, self and social key qualifications. Thus it prepares for challenges in the future working practice.
<b>Language:</b>
The language of the project work and colloquium is German.
<b>Teaching Methods:</b>
Lectures, group work, case studies, self-study, students' presentations.
<b>Module Applicability:</b>
B.Sc. Business Administration.
<b>Pre-requisites/Requirements:</b>
Admission to study Business Administration for a Bachelor's degree.
<b>Examination Types:</b>
The topic supervisor determines the requirements of the exam in the form of another examination type (§ 6 (2), § 7 (2) of the examination regulations for the master's degree of Economics).
<b>Requirements for Award of Credit Points:</b>
Successful participation in the project work. The project work will be passed if the grade is at least „sufficient“ (4,0). Classroom events can be compulsory by consideration of the module supervisor. Regulations of the assigned optional compulsory module have to be considered for the application.
<b>Availability:</b>
The module will be offered at least every second semester. Generally, project works will be offered in each semester according to the optional compulsory module.
<b>Assessment:</b>
This course will be graded and is part of the calculation for the overall grade of the bachelor degree. Particular information concerning the calculation of the overall grade can be gathered in the respective examination regulations.
<b>Person Responsible and Main Lecturer:</b>
Person responsible of the elected optional compulsory module.
<b>Further Information:</b>
Signing in for a project work takes place in the student management and examination administration under consideration of the communicated deadlines (cf. homepage – current news). Information concerning the organisation, planning and colloquium can be asked at the chairs. Further information can be found on the website of the person responsible. The project works (BQ06 and BQ07) have to be taken in two different optional compulsory modules.
